




There was no more business to come before this open session of the Budget, Finance and Audit Committee. The meeting adjourned at 10:16 a.m. by Committee Chair Nelson.

# Written Statement for Closing a Meeting ("Closing Statement")

Date: November 17, 2021

- A. Pursuant to Section 3-305(b) and (d) of the General Provisions Article of the Annotated Code of Maryland, I move to adjourn this open meeting to a closed meeting only to:
  - 14. \_X\_\_ "Before a contract is awarded or bids are opened, to discuss a matter directly related to a negotiating strategy or the contents of a bid or proposal, if public discussion or disclosure would adversely impact the ability of the public body to participate in the competitive bidding or proposal process."

§3-305(b)(14)	The proposals submitted by firms in response to RFP #2252 for professional auditing services for HOC [NOTE: a contract has not yet been awarded].	The meeting must be closed in order to discuss the merits of the various proposals. Public discussion of this topic would adversely impact HOC's ability to participate in future competitive bidding for auditing services because firms would be hesitant to provide necessary confidential and proprietary information and/or would be hesitant to work with the Commission. This could result in HOC not obtaining quality auditing services, which are vital to the agency.
